### What is ARRL Field Day?

ARRL Field Day is the single most popular onthe-air event held annually in the US and Canada. On the fourth weekend of June of each year, more than 35,000 radio amateurs gather with their clubs, groups or simply with friends to operate from

remote locations. Field Day is a picnic, a campout, practice for emergencies, an informal contest and, most of all, FUN!

It is a time where many aspects of Amateur Radio come together to highlight our many roles. While some will treat it as a contest, other groups use the opportunity to practice their emergency response capabilities.

It is an excellent opportunity to demonstrate Amateur Radio to the organizations that Amateur Radio might serve in an emergency, as well as the general public. For many clubs, ARRL Field Day is one of the highlights

of their annual calendar. The contest part is simply to contact as many other stations as possible and to learn to operate our radio gear in abnormal situations and less than optimal conditions.

We use these same skills when we help with events such as marathons and bike-a-thons; fundraisers such as walka-thons;

celebrations such as parades; and exhibits at fairs, malls and museums — these are all large, preplanned, non-emergency activities.

But despite the development of very complex, modern communications systems — or maybe because they ARE so complex — ham radio has been called into action again and again to provide communications in crises when it really matters.

Amateur Radio people (also called "hams") are well known for our communications support in real disaster and post-disaster situations.





### What is the ARRL?

The American Radio Relay League is the national association for Amateur Radio in the USA, representing over 171,000 FCC-licensed Amateurs.

The ARRL is the primary source of information about what is going on in ham radio.

It provides books, news, support and information for individuals and clubs, special events, continuing education classes and other benefits for its members.





## What is Amateur Radio?

Often called "ham radio," the Amateur Radio Service has been around for a century. In that time, it's grown into a worldwide community of licensed operators using the airwaves with every conceivable means of communications technology.

Its people range in age from youngsters to grandparents. Even rocket scientists and a rock star or two are in the ham ranks. Most, however, are just normal folks like you and me who enjoy learning and being able to transmit voice, data and pictures through the air to unusual places, both near and far, without depending on commercial systems.

The Amateur Radio frequencies are the last remaining place in the usable radio spectrum where you as an individual


can develop and experiment with wireless communications.

# Minutes of Board Meeting 23 March 2017 -- 1800 Hours

Participants attending:

There was a quorum so the board could conduct the clubs business. Meeting called to order at 1745 hours by club president, KF6JOQ. Treasurers report called for.

Treasurers Report: Jim, KK6DLN absent due to illness but had sent KF6JOQ a treasurers report which was read to all present and is in the recorded log. Motion to accept treasures report as submitted made by KG6ZBN and 2nd by N6YGG. Motion carried without comment or opposition.

Secretaries Report: All members of the board had been sent a copy of the minutes prior to this meeting. There were no corrections. Motion to accept the minutes made by Mario, N6ABT, 2nd by John, KG6ZZBN. Motion carried.

OLD BUSINESS: The matter of "service pins" that N6YGG had proposed last meeting, was discussed as old business. N6YGG reports that he is in the preliminary stages of finding the pins. The cost would be around 3 to 5 dollars each depending on the style and the number purchased. In addition, N6YGG has still to dig out the longevity of various members so we can determine who would receive a pin. It will take research so more time is needed. Matter tabled.

Larry, KF6JOQ reports that there was an erroneous "rumor" started that "he" wanted to eliminate the 146.91 repeater. Further he had received a list of people who would "resign" from the club if this occurred. He stated most emphatically that he had NEVER recommended the elimination of 146.910. He had stated that we, as a club, needed to at least do something with it. It is inoperable as it is and needs repair. It was his opinion that if we could fix it at a reasonable expense then that would be fine. It stated he felt the repeater was a valuable asset to the club and needed, but it does need to be repaired. He stated he felt a steel pipe with the antenna mounted on it and then bolted to the building would suffice and we would get it back on the air. There was input from all of the board present. Final decision was to proceed with getting it back on the air as soon as possible using the most frugal method we can find. This will be researched further and a team put together to get it done! Larry, restated that at no time, has he ever wanted to eliminate the 146.910 repeater.

After some discussion N6YGG made a motion the club award a \$25.00 gift certificate for the new "logo" for the club, motion seconded by Mario, N6ABT. Motion carried.

Club inventory was discussed and it appears that some items have been located, but finding everything is becoming a task. We will continue to ask the members to help the club reclaim all of its equipment so that it can be inventoried and properly stored.

Other old business that has been before the board for a long time was discussed and includes:

Echo link, where is it and what's up with it. According to Larry, KF6JOQ it is still in possession of Dave Light. The equipment was supposed to be picked up by Jim, KK6DLN, but he became ill so it was never done. Additional discussion made and Mario, N6ABT volunteered to contact Dave and see about the equipment. Larry, KF6JOQ, stated if he had a sound card he could get the system up and running in short order. Club should be able to have an echo link up and running very shortly.

First aid kit discussed and decided we would purchase one before field day this year. No vote taken, no funds authorized as yet.

#### **NEW BUSINESS:**

New badges were discussed and Jon, KK6IFS showed some of his work and he indicated he would make them for members for \$5.00. Membership would be advised during the meeting.

Facebook and QRZ pages have been updated and available for anyone to access. KF6JOQ indicated that the "Facebook" page had been getting some "likes" and activity. He noted Terry, N6AJ, was working with the QRZ page. Club page has also been updated by Frank, KC6UQZ.

New and renewed members were approved.

John, KG6ZBN, stated he hoped to have the producer of "Last Man Standing", a amateur radio operator, would be available to discuss how ham radio has been incorporated into the TV show. The show stars Tim Allen. Method of presentation may be a problem but is being worked on.

Motion to adjourn made by Neal, N6YGG and seconded by John, KG6ZBN. Motion carried adjourned at 18:28 hrs in time for the spaghetti feed!
